He speaks in raw and powerful words of God's deep sorrow over the way people treat each other, over the violence he sees, the anger, the dishonesty, and the political strife. I can only imagine what he would be preaching were he around in our world today. As they say "The more things change the more they stay the same".

I admit it is not hard to lose hope these days. It is not hard to throw up our hands and say "nothing we can do about this mess". I, like you, so often wonder if we are simply on a path to destruction that we cannot change. And just as I am about to throw in the towel Isaiah speaks up again and places a sacred and priceless gift into our hands. He gives us hope. Yes the world is a mess, but then that's nothing new. What is astounding is that even still there are faithful people working hard to bring peace, speaking words of light into a dark world, teaching their children to love, and accept, and appreciate those who seem different from "us".

In your hands you hold our Annual Report. Every year we reflect on what we have done, we give thanks for what has been given and we look forward to what is to come. I know that in the grand scheme of things these pages seem inconsequential. But hidden between the lines of this document is something large, powerful, and life changing. It is the faith of the people who serve this church. Our faith is one of hope, openness and justice. Here you will read about how this year our church fed people who were hungry, kept those who were cold warm, donated over \$24000.00 to ministries all over the world. Together we cared for the sick and we comforted the grieving. We laughed, we cried, we overcame a deficit, we set our feet on a path towards diversity and committed ourselves to work hard at being an open and welcoming place of worship. Together we lived out our faith in real and tangible ways and we proved that even in the darkness there are places where God's light is shining brightly.

Isaiah's vision of a perfect world seems out of reach. But through each one of you, the gifts you offer and this ministry we share, we move forward to a time when the earth will be full of the knowledge of God, our loving, forgiving, life giving God.

Thank you, for the role you played in all of this.

For the youth group it's been about establishing trust and routine, having challenging and comforting spiritual times, and weird and wacky fun events. For the Sunday School there's been the beautiful routine that has been established with their teachers and the CE committee over the years, plus the addition of much mindfulness meditation and new spiritual practices.

Specific events to highlight include:

#### Youth

- Youth coffees and lunches are helping to fill a pastoral care need for our youth.
- Death Cafe was a popular event and co-planned by a youth group member.
- Solo times outside have been really grounding for youth.
- The most popular fun event was the Pajama Party and Movie Night.
- Wonderfully, the most consistently attended and most well attended events are always the youth group nights - our spiritual times together.

#### Sunday School

- Adult Sunday School put on by the children really well received and the kids absolutely loved being the teachers: using their voice and gifts.
- Advent Fest was wonderful and had the addition of Bring an Adult Night for youth.
- The Christmas pageant was huge, with over 45 kids involved.

#### Wider Church

- The addition of Home Church gatherings for young adults.
- In conversation with the public library with two youth group members about starting a city-wide public youth Queer-Straight Alliance club.
- Looking forward to the Affirm committee getting established - what an exciting time!

Looking back on my semester here, I feel very thankful. I'm thankful that my work and my whole self was embraced with such welcome. Nora and Debbie have made everything so smooth and my days so joyful. My youth have given me a sense of purpose and it has been a delight to walk alongside them. The kids have given me unconditional love. Much thanks to the pillars of volunteerism Sam Peters and Staci Hayes, my colleagues. I'm thankful to my discernment committee for our exploring together, and I'm thankful to everyone in the congregation: your words and smiles remind me I am home.

- Harvey Agnew reviewed the budget for the year 2016.

**MOTION:** Harvey Agnew moved and it was seconded by Dave Towers that the budget be accepted as presented. **CARRIED.** Dave Towers thanked Harvey for all his hard work.

#### Nominating Committee Report:

Dave Towers presented the nominations committee report as follows: Mr. Chairman I would like to present the names of those who have allowed their names to be our representatives for 2016 Council and its committees. When it comes to the actual committees, to save time, I would like to read the names and committees and ask for nominations from the floor. When I am finished, I will make one motion to accept all committee nominations.

Several people have agreed to let their names stand for various positions on Council and some positions remain vacant, so on behalf of the nominating committee, I present the following:

For the position of Corresponding Secretary there were no nominations from the floor so the position is vacant.

For the position of Vice Chair of Council, John Moody has accepted and there were no nominations from the floor. **MOVED** by Dave that nominations cease. He also moved the appointment of John Moody as Vice Chair and it was seconded by Staci Hayes. **CARRIED.**

For the position of Chair of Council, Neil Raas has accepted the role. There were no more nominations from the floor and it was **MOVED** by Dave Towers that nominations cease. **MOTION:** It was moved by Dave Towers and seconded by Kathie Edwardson that Neil Raas be appointed as Chair of Council. **CARRIED.**

We have 4 Trustees on Calvary Council. Vi Hannah has resigned, and Shirley Stobbs has agreed to become a trustee.

Mr. Chairman, I, Dave Towers **MOVE** that we accept the resignation of Vi Hannah and appoint Shirley Stobbs to the position of trustee.

**MOTION:** Moved by Dave Towers and seconded by Dorothea Herron that we accept the appointment of Shirley Stobbs as a Trustee. **CARRIED**

It was noted by Dave that the membership thanks Vi for her years of service.

A document outlining the members of the various committees was prepared and was elected by one motion.

Dave read the Committee members list.

**MOTION:** I Dave Towers, move that the committee members per the document be elected to the respective committees. Moved by Dave Towers and seconded by Kathie EdwardsEn. **CARRIED.**

And the final motion from the nominating committee:

**MOTION:** I, Dave Towers, move that the committees be able to add members during the year by presenting the names to Council. Seconded by Staci Hayes. **CARRIED.**

## 6. New Business

Dave Towers presented the JNAC Report to the meeting:

As many of you are aware, Lorelei Clifford had resigned effective June 30, 2016. A Joint Needs and Assessment Committee was formed to determine what was needed in looking for a replacement for her.

Committee members are Kami Karakochuk, Bob Hayes, Harvey Agnew, and Dave Towers from Calvary Church. Larry Chalifour and Dave Whalley were appointed by Presbytery.

We used the 2012 JNAC report as a basis, and updated the details per pages 1 – 8 in the document that was made available to you.

We also reviewed the information given by the 60 respondents in the IMNA survey.

The committee recommended that we go from a half-time position to a ¾ time position, trying to balance between the need and the cost. That motion was defeated at Council, and a new motion passed to hire a full-time replacement for Lorelei's position.

Council felt that to attract the type of person we are seeking, it would have to be full-time. Council also felt that the need has to be focused primarily in youth & Sunday school (this was reflected in the IMNA results as well) as we are burning out our talented core of volunteers in this area.

We amended pages 9 to 13 which deals with the hours of work. The Coles notes on this are as follows – we will increase the hours per week from 20 to 40. The extra 20 hours per week are allocated to the areas of Youth, and Christian Education and Development, as the congregation via the IMNA, your present clergy team, and the JNAC committee see this as Calvary's greatest need at this time.

Mr. Chairman, I submit the 2016 JNAC report.

## FINAL RECOMMENDATION

Joint Needs and Assessment Committee recommends that we hire a three-quarter time (30 hours per week) ministry person to fill a vacant position at Calvary United Church. This person can be Ordained, Diaconal or Designated Lay Supply.

Council rejected this recommendation and opted for a full time – 40 hours per week – ministry person. The above was passed as a motion at the Calvary United Church Council on February 9th, 2016 and will be presented to the congregation for consideration at a congregational meeting on March 6, 2016.

**MOTION:** It was moved by Harvey Agnew and seconded by Merv Benson that we accept the recommendation of Council that we hire a full time person to fill the vacancy on staff.

## 7 Other Business

The meeting was turned back to Neil Raas and he gave words of thanks to Nora, Debbie and Lorelei for all their hard work and to the committee chairs and members for their work that keeps this church going.

8. **MOTION** Bob Gibson moved the meeting be adjourned.

## ACE REPORT

2016 has come and gone. Our main focus throughout the year was the weekly study in which we are still studying the Bible from Genesis to Revelations. With the help of short talks by theologians we cover the main events in each area. All are welcome to join us at 10:00am each Thursday for fun, fellowship and learning.

During Lent we focused on a study titled "Sitting the Dark" . We were challenged by 6 prominent theologians to examine our faith in various ways.

The Advent Study centered on a series entitled: "Interrupted by Faith". We looked at how Advent challenges us to move beyond the everyday demands of time. Advent is a time to move beyond that and move towards a time of new hope , a time to seek a new direction and understanding of tomorrow.

Change is always present either that or we stagnate. Due to several shifts in the life of the Church Adult Christian Education will combine with Worship this coming year. We feel that the combined work is compatible and will benefit both Committees. Thank you to all who have served the church through the years on this committee. The work of Adult Education shall continue with vigor.

## **2016 CALVARY UNITED CHURCH WOMENS' REPORT**

In October we supplied treats and helped with a Bingo for the residents at the Herb Bassett Home. The Craft, Tea and Bake Sale held in November was a successful fundraiser. Also 52 Christmas Plates were made up and delivered to shut-ins in our church community in December.

We catered to 8 funerals, a Sexual Abuse Workshop and Marriage Preparation Class.
